Presidential Message

Dear colleagues and clinic owners:

I hope this letter finds you all doing well. The last year has been challenging for everyone but it appears things are starting to trend in a positive way.

The Board voted last year due to the limited ability to attend face to face seminars to allow all continuing education to be obtained online. The online allowance was for the 2020-21 renewal period only. We made the decision to extend the online continuing education allowance to run with the Governor’s emergency order at our January meeting. The current State of Emergency is set to expire May 7th. If the order is extended then the motion we made during our January meeting would automatically extend the time to obtain all hours online.

The Board has seen a small increase in the face to face seminars, we currently have approximately 150 online seminars and 29 in person options. The ASCA has set their convention for June 11th-12th to be held in per-

The renewal process is much easier if you don’t wait until September to obtain your hours and submit them to the Board. (18 hours are required for renewal each year with part of those in Alabama Law).

2021-22 Renewal Reminder

Per the below motion the Board approved all hours for renewal to be taken online until the end of the Governor's State of Emergency. The Governor's latest amendment to the State of Emergency extends the date to May 7, 2021. Therefore you have until **May 7, 2021** to take all 18 hours online if you choose to do so.

"I move the Board suspend the rule and allow licensees to obtain all CCE requirements with Alabama approved distance-based courses until the end of the Alabama Governor's COVID State of Emergency."

Remember these hours must be Alabama approved and must be taken on or prior to this date and your certificate must reflect the Alabama approval numbers. You should send all certificates to wendy.brewer@chiro.alabama.gov **and only to Wendy**. They should not be sent to others in the office as multiple emails delay the process. You may also fax the certificates to (205-755-0081).
